**Tuition**

Tuition is billed every week and is due in advance of childcare services. Tuition will be due every **MONDAY** morning. Your first tuition payment will be due before you drop your child off for his/her first day at the Learn and Grow Depot. You can pay more than one week in advance, but payment will always be due before care is received.

Tuition is the same regardless of the number of days the Learn and Grow Depot is in session.

Tuition payments should be made at the office in person or left in the locked tuition payment box located in the lobby.

**Termination Procedure:**

This contract may be terminated by either parent/guardian or by the child care provider by giving two weeks written notice in advance of the ending date. Payment by parent/guardian is due for the notice period, whether or not the child is brought to the provider for care. The provider may terminate the contract without giving any notice if the parent/guardian does not make payments when due. Failure by the provider to enforce one or more terms of the contract does not waive the right of the provider to enforce any other terms of the contract.
